### **Annual Meeting & Potluck Luncheon**

The Annual Meeting was held at Quaker Haven Camp Activity Center on June 9<sup>th</sup>. Approximately 45 lake residents were present for the luncheon and approximately 65 residents were present for the meeting.

DNR Office, Jon Cook, was present to answer questions from residents regarding swans, fishing tournaments on the lake and other related lake issues. It was an interesting Q and A and many topics covered.

We appreciated the fine accommodations from Quaker Haven Camp for the room we used and the main entrée for the luncheon. It was a good time to get lake information and meet and speak with other lake residents.

### **Fishing Tournaments**

Some residents who reside near the public boat ramp have complaints stemming from the fishing tournaments that frequent the lake. Parking is a big issue as the lot is not large enough to hold all the cars, trucks and trailers for the fishermen. They park on the streets making it very difficult to navigate the driveways and streets around EMS D24.

Jon Cook, DNR Officer, advised our members at the annual meeting that there is no limit to how many boats can enter Dewart Lake for a tournament. It was widely understood that 15 boats in one tournament was the maximum, but we have now found out this is not correct. The 15 boat limit only applies to several lakes in our area. Lake Wawasee and Syracuse Lake applied for an exemption to the rule and they received it. Their boat limit is now a maximum of 15 boats per tournament.

The Directors voted to have a committee formed to investigate and research the rules regarding fishing tournaments on Indiana lakes. The committee will report back to the Directors with information as to our rights in this situation and what action we can take.

### **Paragraphs from the President**

What a difference a year makes!! We have more water, cooler temperatures, a bald eagle fledgling, and lots of Girl Scouts using the lake. We also have about the same number of Mute Swans as last year. The Mute Swans will be the main topic of discussion at the September 9<sup>th</sup> Lane Directors meeting. Everyone is invited to join us to help make the DLPA Mute Swan policy for the future.

The weevils survived the winter and more were placed in the lake in June. Samples from last year's weevil sites indicate the weevils were present this spring and are causing some damage to the Eurasian Watermilfoil (EWM) stems. In fact, the site west of the island had so little EWM that no additional weevils were placed this year as was originally planned. Two new sites were added this year – one near Quaker Haven Camp and one near the public access channel.

No one knows for sure if the weevils have already caused this year's overall decline of EWM. The decline and lack of "topping out and forming a mat" is most likely related to weather, higher water levels, and poor lake clarity in June. If the weevils are in fact an effective control in the future, we expect the lake to look something like it does this year – EWM still present, but not mat forming. The DNA LARE program, who is paying for 80% of the \$25K annual cost for the first two years, has asked us to apply for another LARE grant for the final two years of the weevil program. The DNR seems pleased with the early results of the program. If this biologic control method works on at least some Indiana lakes, the chemical control cost savings to the DNR statewide will be significant.

Please continue to be a good steward of our beautiful lake.

1. Do use lawn fertilizer sparingly, and use the "Zero Phosphorus" type.
2. Don't put anything in the lake such as lawn clippings, leaves or animal droppings.
3. "Power up" your watercraft only in deeper water. Propeller bottom disturbance uproots beneficial weeds and puts sediment, nutrients, and chemicals (like methyl Mercury) into the water column.
4. Don't feed any wild animals.
5. Make sure your septic system is operating properly. Have your tank pumped every few years to ensure that solids don't get into your drain field and plug it up.
6. If you clear weeds from your pier/beach area (625 sq ft is allowed without a permit) don't use a copper sulfate product because of potential damage to the weevils.
7. Always think "Safety First" when enjoying your watercraft.
